- Acknowledge, agrees, and represents that he has or will immediately upon entering any such restricted area, and will continuously thereafter, inspect the restricted areas which he/she feels and unsafe, he/she will immediately advise the officials of such and will leave the restricted area and /or refuse to participate future in the event(s).
- 2. HEREBY RELEASES, WAIVES, DISCHARGE AND COVENANTS NOT TO SUE the promoter, sponsors, advertiser, Midwest Puller Association and its sanctioning association or and subsidiaries, track operators, track owners, officials, vehicles owners, drivers, pit crews, rescue personnel, any person in any restricted areas, promoters, sponsors, advertiser, owners and lessees of premises used to conduct the event(s), all for the purposes herein referred to as "Release". From all Liability, to the undersigned, his personal representatives, assigns, heirs, and next of kin FROM any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned arising out of or related to the event(s) whether caused by the negligence of the "Releases" or otherwise.
- 3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releases and each of them from any loss, liability, damage or cost they may incur arising out of or related to the event(s) whether caused by the negligence of the releases or otherwise.
- 4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK or bodily injury, death, or property damage arising out of or related to the events(s) whether caused by the negligence or Releases or otherwise.
